Securing Your Agentic Workforce: From Blind Trust to Zero Trust We have been calling AI a coworker, a teammate, a copilot — even a friend. That language is not just imprecise. It is a security risk. As organizations put AI agents to work across their operations, questions around autonomy and accountability become crucial. Who is responsible for an agent's decisions? How much autonomy is appropriate? And what does effective governance look like as agents take on more complex tasks? In this high-energy keynote, Noelle Russell, the #1-ranked Agentic AI Thought Leader globally, delivers the reframe that security and identity professionals have been waiting for: AI is not your coworker. It is a contractor. Having built AI solutions at Amazon, Microsoft, IBM, and AWS, she explores the three autonomy levels of responsible AI: Human-in-the-Loop, Human-on-the-Loop, and fully autonomous systems, helping leaders understand how governance evolves as agents take on greater responsibility. She also introduces the concept of the Sponsor field, the accountability mechanism that stays constant even as an agent gains greater autonomy. Audiences leave with a five-step Agent Onboarding Checklist, a maturity ladder for assessing organizational readiness, and one insight that reframes everything: you can increase autonomy. You cannot outsource the responsibility.
